# Councillor Reynolds:

**Theft of GPS from Tractor –** Farmer Phillip Kitto has reported the theft of a very expensive GPS from his tractor, CCTV is not clear enough to identify suspect. Police have been informed.

**Pot Holes –** Between 5 – 6 Bucklawren Road and Treveria Farm. The Clerk to report.

**Simmons Lane –** Fly tipping. The Chairman to supply photos. The Clerk to report to Cornwall Council.

B3253 Looe Bay - Flooding now worse than ever. The Clerk to contact Cormac.

**Valley Resorts –** Councillor Lawes had a long meeting with Spencer from the company who agreed that warning signs will be erected on the cliffs. The beach bar will not reopen again, however the café may well reopen. Toilet facilities will be provided for the summer season. Discussions have taken place with South West Water about connecting the holiday village to the mains sewage services. Future plans for the resort to be presented to the parish council shortly.

## **County Councillor Armand Toms:**

**Highways Meeting –** With Vickie Frazer to take place, Councillor Toms to ask about the completion of the unfinished work on the B3253 at No Man's Land.

Landslips will also be discussed following the recent 5 falls.

**SW Coast Path** – A large hole has opened up on a stretch of the coast path, contractors are due on site shortly to establish the cause and how to repair.

**SW Water, dye release –** 13<sup>th</sup> March a repeat dye release will take place to try to establish where pollution enters the sea.

**Increased crime in the area –** Theft is the most common crime is SE Cornwall, with rural crime on the increase. Please ensure all valuables are well secured and outbuildings locked.

#### PCSO Dave Billing:

**Police Report -** Firstly, please pass on my apologies for not being able to make tonight's meeting due to not being able to change my shift due to other work commitments. I shall attend April's meeting when I'm planned to work a late shift.

During the month of February 2024 there was one crime in the public domain reported within the Parish. This was a theft of a gas bottle from a holiday park.

The Enquiry Office at Looe Station was officially open on 21st February where a young pupil from Looe Primary Academy had the privilege of cutting the ribbon.

The Opening hours are Monday – Saturday 1000-1500.

Within the last week we have had a couple of GPS units stolen from tractors within the Looe area. If possible, these units need to be removed from the tractor when not in use, although this isn't idea it prevents the units being stolen.

Dear Mr Hyde

Thank you for your letter received on 06 February 2024

I would first like to apologise if you feel as though South West Water have fallen short in the treatment and operations of our Waste Water Services, we strive ourselves to consistently improve our network and reduce overall pollution risk.

You have mentioned Millendreath Beach and what work South West Water is conducting to reduce the impact to the environment in this region.

To help reduce the risk of environmental impact from our sewage network, and to contribute towards improving bathing water quality at Millendreath Beach, we have earmarked circa £100,000 of investment up to March 2025.

We have found that an area of road is draining into the sewage network upstream of Plaidy Pumping Station. This increases volume through our sewage network in periods of rainfall and so we are evaluating how this can be removed to reduce storm overflows operating. We are aiming to complete this by 2025.
